Digitisation put into practice - the focal point of the 34th International Supply Chain Conference

→ 34th International Supply Chain Conference From October 25 to 27, 2017 it will once again be that time of the year when experts and pioneering thinkers in the field of logistics come together in Berlin for the International Supply Chain Conference of BVL. The association has chosen "Think different – Act digital" as the theme for the 34th ISCC, underlining the conviction that what we now need to do is put digitisation into practice – digitisation as a change in the way we think and act: faster, more courageous, more customer-focused and more collaborative. The conference theme can be seen as a clear call to action. No fear of technology and progress, that is what will take us forward. Trying out the seemingly impossible, testing innovation solutions, not allowing setbacks to throw us off course, working in teams. In a nutshell: "Think different – Act digital". The 34th International Supply Chain Conference will provide inspiration and stimuli in this direction.

International speakers have also already confirmed their participation at the conference: on Thursday afternoon, Soumitra Bhattacharya, Managing Director of Bosch Ltd. and Regional President of the Bosch Group India will take part in a plenary session with an international focus moderated by Robert Blackburn. Chief Executive Officer of Hoffmann GmbH Qualitätswerkzeuge in Munich and Vice-Chairman of the BVL Board.

But for all the pioneering spirit and constant change, there are good traditions that will always be retained. On day one of the conference, BVL will once again organise a Gala Evening with stage show. It is also during this festive evening that the winner of the German Award for SCM 2017 will be announced and the guests can find out more about the project selected for the award by a jury made up of experienced experts. www.bvl.de/iscc

### The Road from Big Data to Usable Knowledge

→ Forum Automotive Logistics The Forum Automotive Logistics from February 14 to 15 at the Mercedes-Benz plant in Bremen was attended by some 530 participants, and 60 exhibitors used the event to showcase their solutions and services. The theme for the event was "Smart instead of Reactive – On the Road to Digital Dimensions". In the words of Matthias Wissmann, President of the Association of the German Automotive Industry (VDA), "digitisation will fundamentally change the way we build automobiles. In the automotive industry, we are working at high speed on the systematic digital interconnection of our entire supply chain. Automotive logistics is a key element in this process: in future, it will have to process previously unknown amounts of information more efficiently and faster than ever before". During the Forum, Prof. Raimund Klinkner, Chairman of the BVL Board, said that "the key factor in the global success of the automotive industry is its dynamic pace of innovation. The digital transformation of the automotive value added networks has picked up speed." In addition to the presentations by experts in automotive logistics, the Forum also shed some light on other important areas. The speakers included BVL Board members Frank Dreeke (BLG Logistics) and Frank Wiemer (Rewe), who outlined the viewpoints of logistics services and the trading sector. Dr.

Frederic Speidel from the IG Metall trade union presented interesting insights into the changes at the workplace. Carsten Hernig (Jettainer) and Dr. Klaus Staubitzer (Siemens) outlined the best practice approaches adopted by their companies. Dr. Markus Kückelhaus (DHL) and Frank Wernecke (Drone Masters) spoke on the topic of autonomous logistics processes and future scenarios. The Forum in Bremen was the fifth sector summit for automotive logistics organised jointly by VDA and BVL; the Forum has its origins in two separate events of the two organisations. The first joint Forum was staged in Munich in 2013, and was followed by events in Frankfurt and Leipzig, and once again in Frankfurt last year. With around 500 attendees at each Forum combined with large, varied exhibitions, the two organisations have created an attractive meeting place for logistics managers from the automotive sector and service providers. The mix of presentations, networks and company tours at the end of day two of the event has also proven their worth as an integral part of the programme. The sixth Forum Automotive Logistics of BVL and VDA is scheduled to take place in Frankfurt on January 31 and February 1, 2018.

### The End Customer Sets the Pace

→ Study The BVL study on "Trends and Strategies in Logistics and Supply Chain-Management was published in mid-March and provides a comprehensive analysis of the current situation and the future scenarios in the logistics sector. The study identifies 15 trends. The key insight is that the digital transformation calls for a systematic and actively organised process of change within companies. In the era of digitisation, cost pressure, individualisation and complexity are still the main external factors that pose a challenge to today's companies. The most important endogenous trends are the digitisation of business processes and the greater transparency of the supply chains. The key driver for all players, however - and this development is relatively new - is the end customer.

Just under three in four study respondents describe the opportunities arising for their company as a result of the digital transformation as very good or good. At the same time, more than one in two companies want to hold back their own projects until proven solutions are available. One in three respondents point to the high or very high risks associated with digitisation. The reasons for this could be the required investments in tangible assets, a lack of personnel or the major need for action in the area of qualification in order to prepare employees for new processes, ways of thinking and business models. According to Prof. Wolfgang Kersten from Hamburg University of Technology who headed the study project, "the latest time that companies should engage the challenge of digitisation is now". He said that, in this endeavour, the key is to take account of innovative technology concepts, changes in the value added chain and changing competence needs and then to develop new adapted business models. The study addresses all four fields of action and interlinks them with the 15 trends that influence the strategy and practice of logistics.

### Logistics Sector Still on the Road to Success


Development of digital business models is generally a boardroom issue

► Logistics indicator It was already apparent at the BVL/VDA Forum Automotive Logistics at the Mercedes-Benz plant in Bremen in mid-February that the sentiment among logistics managers in industry, trade and services in the first quarter of 2017 was one of calm and optimism. The discussions were dominated not by geopolitical events but by strategy and practice – and above all by the potentials and risks of digitisation, a process that affects all fields of activity in supply chain management and logistics.

Moreover, the German Ministry of Economics has reported that the national economy grew by 1.9 percent in 2016 after adjustment for inflation, that unemployment is at its lowest level for 25 years, and that Germany has once again set a new jobs record with more than 43.5 million people in gainful employment. The report goes on to say that average net wages and salaries have increased by more than 1.4 percent a year in real terms since 2013. The persisting uptrend on the domestic front is being driven by consumer spending and investment in housing - and the positive effects are clear: the climate score for the Logistics Indicator showed a further increase over Q4 2016 and is now at its highest level since the autumn of 2011.

The climate scores for both sides of the market are around ten points above the average Indicator score over the last ten years. Long-term expectation scores for all market participants are at least stable or better – a sign of the robust overall situation. The majority of respondents forecast a net improvement in logistics business over the next three months. It is hard to imagine a more euphoric mood.



The responses to the supplementary question in the Indicator poll revealed that the development of new digital business models in industry, trade and services is driven by the management in over 60 percent of companies. Roughly half of the companies say that they have received clear signals from their customers that they want innovative solutions. The majority of companies take calculated risks in the innovation process and accept mistakes as a creative part of this process. Less than five percent of respondents believe that they cannot afford to make mistakes in any process, including the innovation process.

Taken together with the insights gained from the study "Trends and Strategies in Logistics and Supply Chain Management" published by BVL at the beginning of March, these results are a positive sign that we will be able to master the challenges presented by digitisation. The digital transformation will be the dominant theme in 2017 – strategically, tactically, operationally, in the area of investment in physical resources and on the qualification front. With the work it performs and the content it provides, BVL addresses these issues head-on, and the association has chosen "Think different – Act digital" as the theme for the year and for the 34th International Supply Chain Conference this October. The buoyant business situation will help the logistics sector to pursue targeted new strategies without undue hesitation.

# Students from Hangzhou Visit the DAV

→ Exchange From December 5 to 7, 2016 eight Chinese logistics students from Hangzhou paid a visit to the German Foreign Trade and Transport Academy (DAV) together with their lecturer. The trip by the group of Chinese students was their reciprocal trip to the Campus based on the Memorandum of Understanding between the DAV and the Zhejiang Institute of Communications in Hangzhou, China. The aim of the visit was to provide the students with important insights into Germany both as a logistics location and as a "green environment". The main significance of the latter aspect is that China signed the climate pact in 2016. Accordingly, the schedule included a visit to the Klimahaus in Bremerhaven, where the Chinese students were given a tailored tour focusing on

the global climate, complete with an abundance of information on the earth's various climate zones. This was followed by a second tailored tour of the BLG container terminal, where former skipper Hans Mangels showed the container gantry cranes – made in China by ZPMC – to the Chinese visitors. The Asian guests were particularly interested in the differences in length between the German and Chinese

container terminals. One of the other items on the programme for the visitors from Hangzhou was a tour of Bremen – a Hanseatic city without a port. The DAV students also made the most of the guests' presence, demonstrating their intercultural communication skills by holding two English-language presentations on China and Germany. This is a business skill that is part of the daily student routine in Bremen.

Guests were accompanied and guided through the production-lines that produce catalytic converters. The plant produces systems for selective catalytic reduction as well as PremAir ozone decomposition catalysts for use in vehicles. The group was also led to the logistics warehouse, where it was able to observe a fully automated storage system. The automated warehouse system can be optimally integrated into the manufacturing and sales processes of a company and optimally adapt to its needs and requirements. Such an automatic system increases reliability and efficiency, while at the same time, significantly reduces costs as well as storage space.

### Site Visit at Kronospan



► Luxembourg The BVL Chapter Luxembourg, together with Cluster for Logistics, staged a joint visit at yet another Hidden Champion from the Grand Duchy of Luxembourg. On 14th March, the wood processing company, Kronospan S.A. in Sanem, best known for its laminate and wooden floors, opened its doors to 25 guests, offering them an insight to its sophisticated logistics processes.

Kronospan, founded in 1897 in Austria, employs over 14000 employees worldwide, 260 of which are employed in Luxembourg. In addition to the Kronobuild, Kronoart and Kronodesign brands, Kronospan also produces floor coverings under the Kaindl brand, the name of the company's founding family. The company has a global orientation, but the business in its philosophy remains a family business.

"Logistics is important for every company: it is vital for us, and is decisive for our competitiveness," emphasised Kronospan CEO Peter Stadler, when he presented the family company and led visitors through the enormous production halls. The size of the company with its various production lines is considerable. With a coach, the participants were led through Kronospan's factory halls, to get an overview of the huge presses and drying equipment required for laminate production.

Uwe Marx, Timber Procurement Manager of Kronospan, has explained the connection of wood procurement with the complex logistical processes. Logistics accounts for a high proportion of costs and requires a modern IT-driven management system. The investment is worthwhile in the face of the diverse procurement and sales channels – which are sold to DIY stores and industry. Wood needs space and the storage capacities of the company cover over 30,000 m<sup>2</sup> in Luxembourg.

After the company presentation and tour, there was a networking session. Guests and employees were able to exchange ideas for a little drink. The challenges of the Sanem site were explained very much by the representatives of the logistics department. The company management along with the BVL Chapter Luxembourg Team spoke to a mixed crowd from Luxembourg and Germany. The BVL Chapter Luxembourg was founded in 2013 and the visit to Kronospan was the 12th Chapter event organised by the Chairpersons Malik Zeniti (Cluster for Logistics) and Thomas Mayer (IEE).

# Letter from ...

# ... the Singapore Chapter: Andreas Radke, Chairperson

Despite the many challenges, logistics and supply chain services remain a key pillar for Singapore's economy due to the country's status and its innovative initiatives.

Singapore's economy has seen sluggish growth and the logistics and supply chain sector contributed unevenly. Air freight cargo through Changi Airport had a record year in 2016, and investments in logistics properties in Singapore remains strong, but individual companies saw declines.

The key industry players, many of them BVL corporate members, continue to see Singapore as a prime location. And with over 10%, our industry and its related branches con-





tribute measurably to the country's development. Each year several thousand graduates form universities and polytechnics enter the logistics and supply chain job market.

The recent nervousness about China's one belt-one road (OBOR) initiative, which could change the centre of gravity of major trade routes away from the Malacca Strait, is evident but nowhere certain. After signing the memorandum of understanding, the long announced investments into the Kra Canal in Southern Thailand have not materialised until now. On top of this, the investments in Malaysian ports along the east and west coasts complete with industrial zones and rail links have indeed led to double-digit growth in container volume, yet traffic in the port of Singapore has remained steady for 2016. Indeed, Singapore continues to engage in major projects everywhere in Asia. From a deepening of investment into Chongqing's transport connectivity, to expansion in particularly the Indonesian market.

Furthermore, Singapore expands its strengths in political predictability, rule of law and efficiency with manifold directions of innovation. Singapore remains a leader in urban planning and vibrant start-up scene in logistics (urban logistics and same day delivery, logistics IT systems, ecommerce, etc.) too and the government actively supports key areas in research and development. The local workforce is highly educated and local graduates are well qualified to enter the job market. Additionally, Singapore's government invests in life-long learning with the Skills Future scheme. Plus, the recently unveiled Attach and Train scheme chose the logistics industry as a testbed to train workers without needing to formally employ them.

► LOGY Conference Every year, the Finnish capital Helsinki is host to Europe's secondlargest logistics conference - the LOGY Conference staged by the Finnish logistics association of the same name. Curtis Campbell Saqladi, the contact and coordinator at BVL head office for international members, activities and partnerships, represented BVL at this conference organised by our sister organisation in the far north of Europe in February 2017 and took advantage of the many opportunities to maintain cross-border contacts. Just under 25 speakers from the host nation, Europe and North America addressed the topic of "Transform Your Business" before around 600 participants in the Finlandia Hall. 
## BVL Special-Topic Forums at the transport logistic
