High Solidarity among Members



This year's BVL's Ordinary Members Meeting was broadcast online from the StreamLab Studios in Bremen on May 3. Votes were cast by transferring them to the few members present in the studio. A total of 181 members were represented this way. Managing Director Uwe Peters explained, BVL had realized three-quarters of its revenue from personal events in 2019. In 2020 those revenues had declined by 85 percent. BVL is countering with a strict cost-cutting and restructuring program, and will also have to calculate with future reduced revenues from the event-business in 2021. The 2020 financial statements and the 2021 budget were approved by the members. They also unanimously discharged the board and the auditors, each with their own abstention. In order to strengthen the income side of BVL, board and management put forward an increase in membership fees, differentiated by member groups starting in 2022 and a special levy for 2021. These two measures, strengthening BVL's financial scope for implementing its Forward Strategy 2025, were also confirmed by the members. The board and management expressed their thanks for the solidarity with which the members support their association and distribute the load on many shoulders. In addition to numerous honorings, the board elections took place. All current members of the board can be found on the BVL [website](#).
